THE CENTERS FOR MEDICARE AND MEDICAID SERVICES (CMS) HAS CERTIFIED IDN TO FUNCTION AS THE SINGLE ORGAN PROCUREMENT ORGANIZATION SERVING THE STATE OF IOWA. IDN ALSO PROVIDES TISSUE RECOVERY SERVICES. IN 2015, ORGAN RECOVERY SERVICES GENERATED \$10,626,292 IN REVENUES WHILE TISSUE RECOVERY SERVICES CONTRIBUTED \$8,461,571 TOWARD REVENUES.
